

2025 SCHEDULE RELEASE SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2025 Schedule Release Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia, except New York, Florida and Rhode Island, and who are eighteen (18) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”), Ticketmaster L.L.C. Sweepstakes period begins on Monday, May 12, 2025 at 12:00:00 p.m. Eastern Time (“ET”) and ends on Friday, May 23, 2025, at 11:59:59 p.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

During the Sweepstakes Period, you may enter by going to <https://forms.philadelphiaeagles.com/f/2025scheduleleasesweeps>, clicking on the icon to access the entry form during the Sweepstakes Period and entering date of birth and country of residence and then your first name, last name, email address, phone number and zip code, checking the box that you agree to the Official. Subject to the conditions below, you will automatically be entered into the Sweepstakes. The Eagles’ computer shall be the official clock of the Sweepstakes.

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about Tuesday, May 27, 2025. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner will be notified by phone within approximately one (1) day of the drawing. If, after two (2) attempts contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as the winner depends on verification of eligibility as determined by the Eagles. Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

In accordance with these Official Rules, one (1) winner will be awarded the following prize: two (2) tickets and two (2) Ticketmaster Tunnel Club passes to one (1) Eagles regular season home game of the winner's choosing during the 2025 National Football League ("NFL") season scheduled to take place at Lincoln Financial Field (ARV \$770). Seat locations to be determined by Eagles in its sole discretion.

Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period. No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Travel expenses and any other costs associated with attendance at the game shall be the sole responsibility of winner. If the winner's guest is a minor, the winner must be the parent or legal guardian of such guest.
